

13. In exceptional cases and with the prior consent of the fitness center staff, children are allowed to move around the exercise rooms, only accompanied by parents or legal guardians, who expressly and non-transferably bear FULL responsibility for any damage caused by the child.
14. Entry to the gym is prohibited for minors under the age of 15. Children aged 10-15 may only exercise under the supervision of a trained instructor. Parents are responsible for visitors aged 15-18 exercising independently. The instructor assumes responsibility for visitors aged 15-18 for the duration of the guided lesson and the presence of the visitor in the hall where the lesson is taking place.
15. Entry to all premises of the establishment is prohibited to persons: in a state of intoxication, under the influence of addictive, narcotic or psychotropic substances, in dirty or obviously inappropriate clothing, or causing public outrage. In these cases, the operator's staff is entitled to ask these persons to leave the sports complex at any time. If they do not do so, they may be removed from the facility without compensation.
16. The visitor is liable for damage or loss caused by the operator in full, even if it is an unintentional act.
17. It is prohibited, under a fine of up to CZK 10,000, to photograph, film, record or otherwise record the premises of the sports centre without the operator's prior written consent, for all visitors.
18. It is prohibited, under a fine of up to CZK 10,000, to provide coaching services without the operator's prior consent.
19. It is prohibited to organize private events in the premises of the sports center without the prior consent of the operator.
20. It is prohibited to provide coaching services to clients without the prior consent of the operator.
21. When leaving the locker room, the visitor is obliged to empty the locker room and leave it unlocked. He is responsible for any damage caused to the operator by the loss, damage or misuse of the membership card. In the event of loss, damage or misuse, the visitor is obliged to pay the amount of CZK 100 as the cost of replacing the membership card.
22. The visitor is obliged to help the disabled person when using the emergency call signaling system, which is posted on the walls of the toilets for the disabled.

IV. Payment for the services provided

One-time entry: by paying a one-time entry and paying for the service according to the valid price list, the payer becomes a visitor to the sports center, who undertakes to comply with the operating rules and instructions of the VEKTOR sports center staff. At the same time, he confirms that he has read the general terms and conditions and has also read the GDPR rules.

Prepaid admission: Purchasing a course fee, a season ticket, or making a deposit entitles the client to use the sports center services with a discount according to the current price list and for the period indicated for each type of subscription in the price list. Prepaid admission ends with a specified period of validity and unused admission (entries or funds) is forfeited. Prepaid admission can only be extended based on a doctor's certificate of medical incapacity. Entries or cash are added up and the validity is extended for another period with each new prepayment of the admission fee according to the current price list.

Depositing funds through a payment gateway: depositing a financial amount to cover a one-time entry (according to the valid price list) allows the client to book lessons online, book in person at the sports center, and purchase services and goods offered by the sports center. The validity of such an account, where the credit serves only as a "virtual wallet", is not limited in time.

V. Final provisions

These Operating Rules are valid and effective from 1 May 2019. The Operator reserves the right to change the Operating Rules without prior notice.

Violation of the Operating Rules by a visitor is grounds for terminating the visit to the sports center and terminating the contractual relationship between the operator and the visitor.
